Johnson County, Missouri, County Commissioners Announce Rollback of Tax Levies, Saving Property Owners an Estimated \$460,000

WARRENSBURG, MO — The Johnson County, Missouri, County Commissioners held their annual levy hearing at 9:30 AM on August 29th. During the meeting the Commissioners unanimously agreed to reduce the General Revenue and Road and Bridge property tax levies. The General Revenue levy will be reduced from 0.1085 to 0.0900 cents per \$100 of assessed valuation. The Road and Bridge levy will be reduced from 0.2363 to 0.2000 cents per \$100 of assessed valuation. This will provide all taxpayers of Johnson County with a total reduction of 0.0548 on their county levies.

This decision reflects the Commissioners' ongoing commitment to fiscal responsibility and their dedication to easing the financial burden on local taxpayers. The rollback comes after careful consideration of the county's financial health, current revenue streams, and the needs of the community.

"We are thrilled to be able to provide this tax relief to our residents," said Troy Matthews Johnson County Presiding Commissioner. **"This reduction is a direct result of sensible financial management by all of our county officials and our commitment to serving the best interests of Johnson County's citizens."**

The \$0.0548 rollback will be applied across the board to all property taxes within Johnson County, providing immediate relief to homeowners, business owners, and agricultural property owners alike.

"Every dollar counts, especially in today's economic climate," added Charlie Kavanaugh, Western Commissioner **"By reducing the tax levy, we hope to make a tangible difference in the lives of our property owners, keeping more money in their pockets while still maintaining essential county services."**

The rollback will take effect with the next billing cycle, and residents can expect to see the savings reflected in their upcoming property tax bills.

"This rollback is a reflection of our commitment to being good stewards of taxpayer dollars," said Commissioner Matthews. **"We've worked diligently to find ways to reduce costs while still delivering the services our community relies on. This tax reduction is a win for everyone in Johnson County."**
