Dust Control Company Acknowledgement Agreement - Johnson County, Missouri

Beginning January 2019, all companies applying dust control in Johnson County, Missouri will be required to agree to an annual Dust Control Acknowledgement Agreement. Upon the completed agreement being returned to the County Clerk's Office (jpowers@jococourthouse.com or Fax: 660-747-9332), the Dust Control Company's contact information will be provided to Johnson County Residents seeking to purchase dust control in Johnson County. Dust Control Company Lists will be available through the Road and Bridge Department, County Commissioners, County Clerk and the county website (jococourthouse.com/road_bridge.html).

Below is an excerpt of the Dust Control Requirements from the 2018 Johnson County Amended Rules and Regulations for Establishment, Acceptance and Maintenances of County Public Roads and Platted Subdivision in Johnson County, Missouri (complete document available at www.jococourthouse.com or by calling 660-747-6161).

DUST CONTROL REQUIREMENTS:

- 1. All dust control products **must be approved** by the Johnson County Commission.
- 2. Johnson County will not be responsible for any damage caused by a product used for dust control.
- 3. Landowners will pay for all dust control products applied to roads.
- 4. All products must be approved by the Environmental Protection Agency.
- 5. At the time of application, the landowners will be required to display appropriate signs at the starting and ending points and at any intersecting roads in between.
- 6. The Johnson County Commission must be notified in writing at least one (1) week in advance of the application of any dust control product.
- 7. Johnson County will do everything possible not to disturb the product applied to the roadbed. If it becomes necessary to maintain the road for any reason, work required to keep the roads safe will be done. The county will not be responsible for loss of dust control product due to road maintenance.
