To whom it may concern,

Johnson County will accept bids for approximately 83,856 square yards of type III (Missouri specification JSP section 413.10) limestone micro-surfacing with a minimum of 30lbs per square yard. All micro-surfacing must be a continuous run on each of the following county roads; SW200 between BB Hwy and 58 Hwy, SW200 between SW951 and SW250, and NE151 between NE200 and 13Hwy.

There will also be approximately 30,976 square yards of ISSA Type II scratch leveling course (using Missouri Specifications) for repair of light rutting in county road SW200 between SW951 and SW250.

Additionally, on county road SW200 from BB Hwy to 58 Hwy, there will be approximately 3511 linear feet of crack filling using a 6690 crack fill compound or comparable crack filler. The crack filling needs to be completed at least 30 days prior to micro surfacing. All cracks need to have loose material blown out before filling. Johnson County will mark cracks that are to be filled.

Johnson County request the contractor who is awarded the contract shall provide a payment and performance bond within 15 days after contract is awarded. All amounts are approximate and it is the bidder's responsibility to check all yardage and footage of projects. All projects will be bid together as one. The contractor must have all mix designs at time of bid opening. Johnson County will be responsible for traffic control of work areas.
